## **Key Information about the Research Study**

You are invited to participate in a research study. To participate, you must be a graduate of a clinical mental health counseling program within the past five [5] years, be a resident in counseling, and identify as a Christian.

Things you should know:

- The purpose of this study is to better understand the experience of Christian counselors working with cases of religious trauma. If you choose to participate, you will be asked to complete a 5-minute demographic survey and virtual video-recorded focus group that will last about 90 minutes.
- Risks or discomforts from his research include emotional distress due to talking about complex cases and clinical needs as a counselor.
- Participants should not expect to receive a direct benefit from participation.
- Taking part in this research project is voluntary. You do not have to participate, and you can stop at any time.

Please read this entire form and ask questions before deciding whether to participate in this research.

#### What is the study about and why is it being done?

The purpose of this research is to better understand the challenges, emotional impact, and professional considerations that religious counseling residents face when working with individuals who have experienced religious trauma. The goal is to better understand these experiences in order to learn how to best support counselors in training.

#### What will happen if you take part in this study?

If you agree to be in this study, I will ask you to do the following:

- 1. Take a 5-minute demographic survey.
- 2. Engage in a virtual, video-recorded, 90-minute focus group.

# How could you or others benefit from this study?

Participants should not expect to receive a direct benefit as a result of their participation in this research.

Benefits to the counseling field include improving supervision and training for counseling residents working with religious trauma survivors. Your insights may help inform future counseling education and practice.

## What risks might you experience from being in this study?

The expected risks from participating in this study are minimal, which means they are equal to the risks you would encounter in everyday life. Potential risks include the following:

- Emotional distress related to clinical case discussion.
- Limitations for confidentiality due to participation in a focus group.

To minimize these risks, I will monitor participants for emotional or psychological distress and will be provided resources as appropriate. Participants will also be encouraged to discuss any needs or concerns with their clinical supervisor.

I am a mandatory reporter. During this study, if I receive information about child abuse, child neglect, elder abuse, or intent to harm self or others, I will be required to report it to the appropriate authorities.

# How will personal information be protected?

The records of this study will be kept private. Published reports will not include any information that will make it possible to identify a participant. Research records will be stored securely, and only the researchers will have access to the records.

- Participant responses will be kept confidential by replacing names with pseudonyms.
- Researchers will conduct the focus group in a location where others will not easily hear the conversation.
- Confidentiality cannot be guaranteed in focus group settings. While discouraged, other focus group members may share what was discussed with persons outside of the group.
- Data will be stored on a password-locked computer. The researchers will have access to the data. After three [3] years, all electronic records will be deleted.
- Recordings will be stored on a password-locked computer. The researchers will have access to the recordings. After three [3] years, the recordings will be deleted.

# How will you be compensated for being part of the study?

All participants who complete the demographic survey and focus group will be entered into a drawing for one \$15 gift card to Amazon, to be delivered via the email provided in the screening survey.

# Is study participation voluntary?

Participation in this study is voluntary. Your decision whether to participate will not affect your current or future relations with Liberty University. If you decide to

participate, you are free not to answer any question or withdraw at any time without affecting those relationships.

# What should you do if you decide to withdraw from the study?

If you choose to withdraw from the study, please contact the researchers at the email addresses/phone numbers included in the next paragraph. Should you withdraw, data collected from you, apart from focus group data, will be destroyed immediately and not included in this study. Focus group data will not be destroyed, but your contributions to the focus group will not be included in the study if you choose to withdraw.
